24th FIMMDA-PDAI Annual Conference at Bali from 17th April to 20th April 2025

Visa Checklist for Bali

1. Color & clear passport scan copy of Passport details (1st page) and Address (last page) of delegates.

Note: Valid passport criteria

- Passport must have min. 06 months validity from the date of return to India i.e. must have validity till 21st Oct 2025.
- Passport must have minimum 02 blank pages.
- Any water spot marks or any lamination peel off or thread of passport loose or came out of passport should be considered as damage passport and immigration & airlines have every right to deport traveler from the airport. For such cases, reapply passport.
